ORDER

The Government of Rajasthan issued the *Guidelines for Establishment of Private Universities by Separate Act* on 26.07.2007. Subsequently, revised *Guidelines for Establishment of Private Universities by Separate Act* were issued on 10.02.2026.

Government of India has rolled out Phase-II of the Compliance Reduction & Deregulation Initiative. One of the priority areas under this initiative is to 'Eliminate Minimum Land Requirement for Private Universities' (PA-16). In accordance with the recommendations made under this priority area, the following partial amendment in the *Guidelines for Establishment of Private Universities by Separate Act* issued on 10.02.2026 is hereby made with immediate effect:

1. The provisions 9(ii) and 9(iii) relating to the minimum land requirement and Constructed area in the Guidelines dated 10.02.2026 are hereby substituted with the following provision:

“9 (ii) The sponsoring body shall have buildings with a minimum carpet area of twenty-five thousand (25,000) square metres and open space of twenty-five thousand (25,000) square metres.

9 (iii) If sponsoring body owns two plots:

(a) The distance between the two plots does not exceed 2 kms;

(b) have one or more educational institutions of higher education on at least one of the plots;

(c) shall have buildings with a minimum carpet area of Twelve thousand Five Hundred (12,500) square metres and open space of Twelve thousand Five Hundred (12,500) square metres on each plot.”

2. Above provisions will be applicable for all new LoIs to be issued in the future for the establishment of private universities in the State.
3. Except as modified by this Order, all other provisions of the Guidelines dated 10.02.2026 and subsequent order No. F. 3(14)Edu-4/2006-05050-7032831 dated 16.06.2026 regarding the Endowment fund shall remain unchanged and continue to remain in force.
